Mr. Dana T. Yon 61, of Pittsfield, passed away on Monday, May 22, 2017 at Berkshire Medical Center. Born in Pittsfield on October 31, 1955 the son of Joseph Yon and the late Mary Osanni Yon, he was a 1973 graduate of Pittsfield High School and received an Associate's Degree in Business from Berkshire Community College.

Mr. Yon was currently working in Materials Management at Berkshire Medical Center where he had been employed for the past 15 years. He had previously worked at GE Plastics for 9 years.

Dana enjoyed sports and was an avid golfer. He especially enjoyed spending time with family and friends, and doing work around his home. For nearly two decades, Dana was a member at the Berkshire Hills Country Club, where he was a five time winner of the annual Chris Yon Invitational. His one bucket list item was to play the PGA Tour's famous Arnold Palmer's Bay Hill Club in Orlando, Florida. He was able to accomplish this alongside his son Chris in March of this year.

Besides his father, he is survived by his wife, the former Lynn Henault, whom he married on September 11, 1976 at St. Joseph Church. 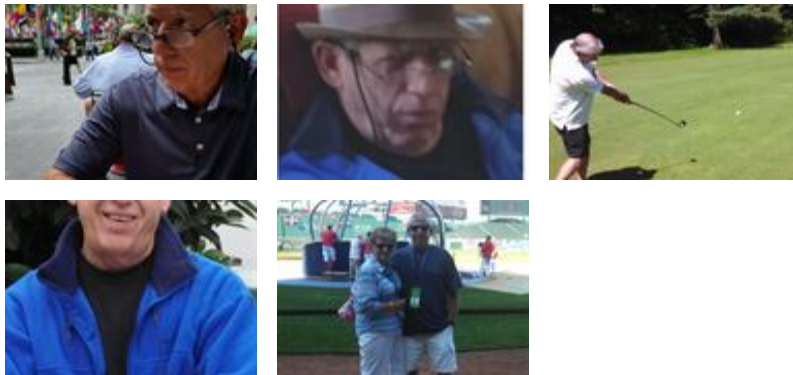
