Mr. Edward F. McDermott III, 81, of Pittsfield, passed away peacefully at his home on Sunday, January 28, 2024. Born in Pittsfield, MA on May 24, 1942, the son of the late Edward and Mary Ann Smith McDermott, he graduated from Pittsfield High with the class of 1961.

Shortly after graduation, Ed enlisted in the United States Coast Guard, where he proudly served his country from August of 1962 until February of 1963.

He was the proud owner of Bellstone Cycle on W. Housatonic St. in Pittsfield. It was there he greeted his customers—always with a smile—and dedicated 53 years, until illness forced his retirement in August of 2023.

Among many things, he mostly enjoyed, his family and his friends.

Edward is survived by his beloved wife of 60 years, the former Arlene Sutherland, whom he married in 1963. He leaves behind sons Edward McDermott (Joanne) and James McDermott (Maria) as well as 6 grandchildren Connor (Kennedy), Colin, Michelle, Cole, Cian and Laura.
