



Mr. Henry "Butch" Maces

November 19, 1947 - June 9, 2024

Mr. Henry "Butch" Maces, 76, of Pittsfield, passed away at his home on Sunday, June 9, 2024. Born in Pittsfield, MA, on November 19, 1947, the son of the late Henry and Evelyn Dean Maces, he proudly graduated from the former St. Joseph High School with the class of 1966 and then served in the Army Reserve.

Butch later began his career in the transformer division of General Electric. It was there he was employed for many years as a foreman until taking over his family's business, Onota Boat Livery, in 1979. With hard work and help from friends and family, he turned the bait and tackle shop into a well-known and competitive boat and service dealership. In 1992, Henry sold the business, and afterward, held many jobs, including driving school buses for Pittsfield Public Schools.

When Butch fully retired, he relocated to the Villages in Florida, where he enjoyed golfing, swimming, and shuffleboard. He was also an avid hunter and fisherman. Four years ago, when Henry was diagnosed with cancer, he moved back to his hometown, choosing to fight the battle with his family by his side.

Henry is survived by his son, Charles Maces (Heather) and Charles' mother, Frieda Bercury Maces, as well as his sister Carol Nicholson. He leaves behind

his grandchildren, Matthew and Jenna, and his nieces and nephews, Cherie Ferber, Daniel Daoust, and Jeremy Nicholson. Butch is also survived by his former brother-in-law, Daniel Francesconi, and his longtime friend Stan from the Villages.

Besides his parents, he was predeceased by his sister and brother-in-law, Kathleen and Paul Daoust, as well as his niece, Annette Bisson.
