Mr. Mark A. Amuso Sr., 88, formerly of Crown Street, Pittsfield died Wednesday morning, January 20, 2016 at Berkshire Medical Center. Born in Pittsfield on August 18, 1927, he was the son of the late Joseph and Marjorie Robertson Amuso. He attended Pittsfield Public Schools which he left before graduation to join the Navy. He proudly received his high school diploma in 2006.

Mr. Amuso was a US Navy Veteran of both WWII in the Pacific Theater and the Korean War.

He was a longtime firefighter with the Pittsfield Fire Department, retiring as Lieutenant.

Mark also worked as an Orthopedic Technician for Berkshire Medical Center for many years and also at the former Lacy ambulance service.
