



## Mr. Sean M. Thomas

July 10, 1974 - October 26, 2024

Mr. Sean Michael Thomas, of Pittsfield, passed away after a long, valiant battle with cancer on Saturday, October 26, 2024, shortly after his 50th birthday. Born in Pittsfield, MA, on July 10, 1974, son of Carl and Mary (Wren) Thomas, he graduated from St. Joseph High School and attended Mildred Elley, earning his paralegal certificate.

Sean enlisted in the United States Marine Corps in September of 1993 where he proudly served his country until his honorable discharge as corporal in 1997. A true Marine, Sean's resilience and grit was evident throughout his life and remained with him right up until the very end. Sean will be remembered by many as the strongest man they have ever known.

In addition to the Marine Corps, Sean held careers in Ballistic Glass, Law and finally in Healthcare. Sean closed out his career at Kimball Farms Nursing Care Center where he gained as much from his patients and colleagues as they gained from his care and friendship.

Among many things, he enjoyed watching the New England Patriots and Boston Red Sox, especially on trips to Fenway Park and Gillette Stadium. enjoyed his Nana's mutton pies, visiting the Irish Village in Cape Cod and sharing meals and laughs with his large Irish family.

He is survived by his parents, Carl and Mary (Wren) Thomas. He leaves his daughter, Kailee Thomas (husband, Jaryd Dulieu) and her mother, Gabrielle Coleman, as well as his son, Kaelen Thomas and his mother, Jaime Marby. Sean is survived by his brother, Kristian Thomas (partner, Rachel McMahon), as well as his sisters, Ashley Thomas, and Mary Roy (husband, Joseph Roy). Sean is also survived by many aunts and uncles, Brenda and Brian Griffin, Eileen Kane, James Wren, Peggy and John Giguere, Rita and Mark Foss, Robbin and Darcy Chapman, and Louise and Tommy Lis as well as many beloved cousins.
