Timothy J Sullivan, Jr. (84) passed away peacefully at his home on Tuesday March 3, 2026, with his loved ones by his side. Born in Holyoke, MA, on April 14, 1941, he was the son of the late Timothy J Sullivan, Sr, and Ruth G Sullivan, and brother to Peter and the late Willis. Tim was salutatorian at St. Joseph High School, and later graduated Boston College undergraduate and Law School. He served in the Army Reserves and began a successful legal practice spanning 50 years. He was known for his integrity and was well respected throughout Berkshire County.

As successful as his legal endeavors were, his greatest joy was the 60 years spent with his lovely bride, Pamela M Hebert. Together they raised four children, Amy S Thomson (Graham), Timothy J Sullivan (Karen), Katherine Gwozdz (Rob), and Christopher Sullivan (Elizabeth). He was also the proud Papa to grandchildren Molly, Bradley, and Abigail, and will be dearly missed by his nieces, nephews, and extended family.

An accomplished musician and singer, Tim was a member of the BC Glee Club, Berkshire Lyric Theatre and Choir Director at St Francis. The focal point of every family gathering was piano and song.

Tim was an avid athlete, enjoying baseball, skiing, and tennis, as well as coaching many of his kids' teams and a long-time member of the Brodie ski

patrol. You could often find him outside stacking wood.

Family & friends will miss his witty repartee, sense of humor and intelligent curiosity. He was a steady force, touchstone and role model for all he loved. "Timo" was one of a kind and will be so greatly missed.

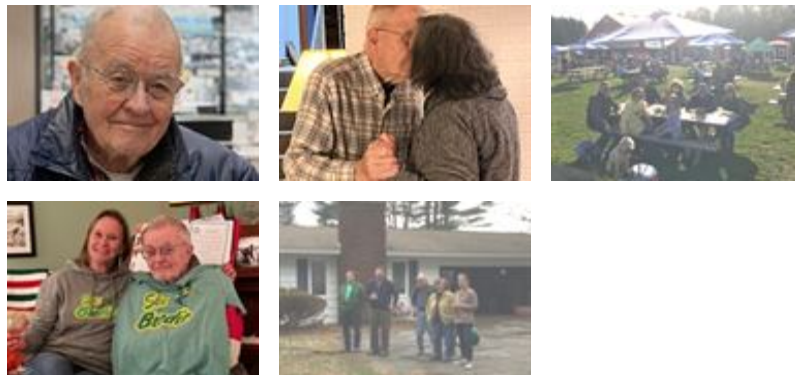
